Specifically, the District will consider adoption of a Resolution Supplementing a Resolution adopted by the Board of the District on March 19, 2025, authorizing the District to issue general obligation and special revenue indebtedness in the aggregate principal amount not to exceed \$166,000,000 consisting of its (i) Limited Tax General Obligation and Special Revenue Refunding First Lien Bonds, Series 2025A-1; (ii) Limited Tax General Obligation and Special Revenue Refunding Second Lien Bonds, Series 2025A-2; and (iii) Subordinate Limited Tax General Obligation and Special Revenue Refunding and Improvement Bonds, Series 2025B (collectively, the "2025 Bonds") for the purpose of refunding outstanding indebtedness of the District, paying the costs of financing or reimbursing costs of certain public improvements, funding a reserve fund or funds for one or more series of Bonds, funding capitalized interest on one or more series of bonds, paying the cost of issuance of the Bonds; authorizing the execution of an Indenture of Trust (First Lien), Indenture of Trust (Second Lien) and an Indenture of Trust (Subordinate); approving other documents and taking of other actions relating to the issuance of the 2025 Bonds and refunding of outstanding indebtedness of the District, as well as the adoption of a Resolution Supplementing a Resolution adopted by the Board of the District on March 19, 2025, authorizing, among other things, the District to enter into the Second Supplemental Indenture of Trust (Junior) supplementing and amending the Indenture of Trust (Junior) dated as of December 1, 2020, as amended and supplemented by the First Supplemental Indenture of Trust (Junior) dated as of March 26, 2025, each between the District and UMB Bank, n.a., as trustee, making determinations and findings as to other matters related to said supplement, authorizing incidental action, and repealing prior inconsistent actions in connection therewith.

The Board will also conduct such business as may come before the Board. The meeting is open to the public.
