Delivered with this letter are the disclosures required by MSRB Rule G-17 regarding our role, duties and interests as an underwriter of the Bonds. By signing this letter agreement, the Client acknowledges and agrees that: (i) the transaction contemplated by this Agreement will be an arm's length, commercial transaction between the Client and the purchaser, in which Davidson may be acting as an agent or as an underwriter, but not as a municipal advisor, financial advisor or fiduciary to the Issuer; (ii) Davidson has not assumed any fiduciary responsibility to the Client with respect to the transaction contemplated hereby and the discussions, undertakings and procedures leading thereto; (iii) the only obligations Davidson will have to the Client with respect to the transaction contemplated hereby are expressly set forth in this letter agreement; and (iv) the Issuer has consulted and will continue to consult with its own legal, accounting, tax, financial and other advisors, as applicable, to the extent it deems appropriate.



The representative of the Client signing this letter agreement has been duly authorized to execute this letter agreement and to act hereunder.

This letter agreement shall remain in full force and effect until such time as the Client notifies Davidson in writing of its intent to terminate this letter agreement. Davidson may resign and terminate this letter agreement by providing written notification with no less than 30 days prior notice to the Client.

At such time as arrangements for the sale of Bonds or other borrowing have been completed, Davidson shall be paid as shown below:

- 0.5% of the par for the underwriting of rated bonds for a refunding of the District's existing bonds
- 2.0% of the par for underwriting of non-rated, subordinate bonds

In addition to such compensation, the following shall be paid by Client as a component of the cost of issuance of the Bonds or placement of the debt: (i) legal fees incurred by Davidson's engagement of underwriter's counsel or placement agent's counsel in connection with the issuance of Bonds or placement of the debt, as applicable; and (ii) legal fees related to third-party review of past continuing disclosure compliance. Unless otherwise agreed to by Client, Client's payment of the foregoing is contingent upon the sale of Bonds or placement of debt.

This letter agreement is not an offer to purchase Bonds. If the sale of Bonds or other borrowing does not occur, Davidson shall not be owed compensation. Please indicate by your signature below your desire to engage D.A. Davidson & Co. Fixed Income Capital Markets to provide investment banking services on these terms.

EXHIBIT A

D.A. Davidson & Co. (hereinafter referred to as "Davidson" or "underwriter") intends/ proposes to serve as an underwriter, and not as a financial advisor or municipal advisor, in connection with the issuance of the Bonds.

As part of our services as underwriter/senior managing underwriter, Davidson may provide advice concerning the structure, timing, terms, and other similar matters concerning the issuance of the Bonds.

Disclosures Concerning the Underwriters Role:

- (i) MSRB Rule G-17 requires an underwriter to deal fairly at all times with both municipal issuers and investors.
- (ii) The underwriters' primary role is to purchase the Bonds with a view to distribution in an arm's-length transaction with the Issuer. The underwriters financial and other interests that may differ from those of the Issuer.
- (iii) Unlike a municipal advisor, the underwriters do not have a fiduciary duty to the Issuer under the federal securities laws and are, therefore, not required by federal law to act in the best interests of the Issuer without regard to their own financial or other interests.
- (iv) The Issuer may choose to engage the services of a municipal advisor with a fiduciary obligation to represent the Issuer's interest in this transaction.
- (v) The underwriters have a duty to purchase the Bonds from the Issuer at a fair and reasonable price, but must balance that duty with their duty to sell the Bonds to investors at prices that are fair and reasonable.
- (vi) The underwriter will review the official statement for the Bonds in accordance with, and as part of, their respective responsibilities to investors under the federal securities laws, as applied to the facts and circumstances of this transaction.

Disclosures Concerning the Underwriters Compensation:

As underwriter, Davidson will be compensated by a fee and/or an underwriting discount that will be set forth in the bond purchase agreement to be negotiated and entered into in connection with the issuance of the Bonds. Payment or receipt of the underwriting fee or discount will be contingent on the closing of the transaction and the amount of the fee or discount may be based, in whole or in part, on a percentage of the principal amount of the Bonds. While this form of compensation is customary in the municipal securities market, it presents a conflict of interest since the underwriter may have an incentive to recommend to the Issuer a transaction that is unnecessary or to recommend that the size of the transaction be larger than is necessary.

Davidson has not identified any additional potential or actual material conflicts that require disclosure.

MUNICIPAL ADVISOR ENGAGEMENT LETTER

EFG-CONSULTING, LLC (the "Municipal Advisor") has been engaged to serve as the Municipal Advisor to the STC METROPOLITAN DISTRICT NO. 2 (Jefferson County, Colorado) (the "Issuer"). This document serves as the written engagement between the Municipal Advisor and the Issuer and sets forth the duties and responsibilities of the Municipal Advisor in connection with the Issuer's estimated \$90 Limited Tax General Obligation Bonds, Series 2024 (the "Series 2024 Bonds").

Section 1: Municipal Advisor Role and Scope of Services. The Municipal Advisor is engaged as a recognized independent expert whose primary responsibility is to give objective advice on the structure and issuance of municipal securities. The Municipal Advisor, also referred to as, the External Financial Advisor, as said term is defined in the Issuer's Service Plan, is a consultant who: (i) advises local governmental entities on matters related to the issuance of securities, including matters such as the pricing, sales and marketing of such securities and the procuring of bond ratings (if applicable), credit enhancement and insurance with respect to such securities, (ii) is a Municipal Advisor duly registered with the Municipal Securities Rulemaking Board ("MSRB"), and (iii) is not an officer or employee of the Issuer and has not been otherwise engaged to provide services in connection with the transaction related to the Series 2024 Bonds.

During this engagement, the Municipal Advisor will provide some, or all, of the following services to determine the fair and reasonable pricing and structuring of the Series 2024 Bonds:

- A. Evaluate and consider financing and legal options and/or alternatives for the issuance of the Series 2024 Bonds taking into account the Issuer's objectives, revenue availability and other factors;
- B. Advise the Issuer with respect to the "Plan of Finance" related to the Series 2024 Bonds; review all supporting material (*Appreciation Study, Market and Absorption Studies, and Cash Flow Projections*) in order to ensure the Issuer has a reasonable idea of the project financing;
- C. Research and determine appropriate high-yield tax-exempt bond comparables to use in evaluating the pricing and structuring of the Series 2024 Bonds;
- D. Ensure fair pricing on the Series 2024 Bonds;
- E. Review and ensure that the Series 2024 Bonds are in compliance with the Issuer's Service Plan;
- F. Engage with the Issuer, the Underwriter, Underwriter's Counsel, Disclosure Counsel and Bond Counsel to develop necessary documentation to finalize and close the Series 2024 Bonds; and

G. Provide a Certificate of Financial Advisor with respect to the fairness of pricing and structuring the Series 2024 Bonds *(including the provision of an opinion from the Municipal Advisor in accordance with the Issuer's Service Plan).*

Section 2: Disclosure of Conflicts of Interest. Rules established by the MSRB and the Securities and Exchange Commission (SEC) require the registered Municipal Advisor to provide a written description of any material conflicts of interest, including any plans to mitigate any such conflicts of interest. This means several important things:

- A. the Municipal Advisor has a duty to exercise due care in performing municipal advisory activities;
- B. the Municipal Advisor has a duty of loyalty, requiring advice to be rendered in the best interest of the Issuer, without regard to the financial interests of the Municipal Advisor;
- C. the Municipal Advisor must have the knowledge and expertise needed to provide the Issuer with informed advice;
- D. the Municipal Advisor has a duty to understand the Issuer's specific financial circumstances so that any advice may be deemed suitable to the Issuer's situation; and
- E. the Municipal Advisor has a duty to discuss material risks and benefits with the Issuer to best serve the Issuer's needs.

The Municipal Advisor acknowledges that it will be paid upon successful closing of the Series 2024 Bonds with the Issuer which creates a potential conflict of interest. Other than the potential compensation conflicts of interest, the Municipal Advisor has no other conflicts of interest that would impair its ability to serve the Issuer as Municipal Advisor.

Section 3: Term of Engagement. The Municipal Advisor shall be engaged as of the date of this Engagement Letter and shall remain until the closing and delivery of the Series 2024 Bonds or similar instruments by the Issuer.

Section 4: Municipal Advisor Compensation. The Issuer agrees to pay the Municipal Advisor for the services described in Section 1 above in an amount of \$11,250.00. The Municipal Advisor's fee for services is a contingent fee predicated upon the successful closing and delivery of the Series 2024 Bonds or similar instruments of the Issuer.

This engagement shall take effect upon action by a duly authorized representative of the Issuer and Municipal Advisor to approve this engagement.

V. MSRB ADDENDUM

To the extent any material conflicts of interest arise after the date of this agreement, MuniCap will provide information concerning any material conflicts of interest in the form of a written supplement to this agreement.

As part of this registration, the MuniCap is required to disclose any legal or disciplinary event that is material to the District's evaluation of the MuniCap or the integrity of its management or advisory personnel. The MuniCap has determined that no such event exists.

AGREEMENT FOR CONSULTING SERVICES

THIS AGREEMENT is made and entered into as of September 23, 2024, by and between the **STC Metropolitan District No. 2**, hereinafter called "Client," and **MuniCap, Inc.**, hereinafter called "Advisor," for financial advisory services for Client. The Client and Advisor, in consideration of the mutual promises and conditions herein contained, agree as follows.

In consideration of the mutual promises and covenants contained in this Agreement, and for good and valuable consideration, the Advisor and Client agree as follows:

1. This Agreement shall become effective following signature by all parties.

2. A. Advisor shall provide services to Client as described in Exhibit A, which is attached and incorporated by reference.

3. Advisor's compensation for these services shall be as provided for in Exhibit B attached and incorporated by reference. Compensation due to Advisor will be paid upon the submission to Client of an invoice providing for compensation as provided for in Exhibit B. Compensation for additional services not included in Exhibit A shall require the approval of Client.

4. Client shall provide access to all documents reasonably necessary to the performance of Advisor's duties under this Agreement. Except as may be necessary for performance of this Agreement, and to the extent not already generally known as available to the public, the Advisor shall not use or disclose information concerning Client without prior written consent of Client.

5. Advisor agrees to maintain in confidence, to refrain from disclosing to third parties, and to use only for the purposes intended by this Agreement all information which Advisor obtains from Client related to the project or which Advisor develops under this Agreement, except to the extent expressly permitted by the prior written consent of Client, specific information is released to the public by or with the consent of Client (e.g. the official statement for the issuance of bonds), or as required by law, regulation, or legal process.

6. In performance of work and services under this Agreement, Advisor shall act solely as an independent contractor, and nothing contained or implied in this Agreement shall at any time be so construed as to create the relationship of employer and employee, partnership, principal and agent, or joint ventures as between Client and Advisor.

7. Advisor is registered as a "municipal advisor" under Section 15B of the Securities Exchange Act of 1934 and rules and regulations adopted by the Securities Exchange Commission (the "SEC") and the Municipal Securities Rulemaking Board (the "MSRB"). Pursuant to MSRB Rule G-10, Advisor (MuniCap, Inc.) is required to provide Client with the following information:

- A. Advisor has determined, after exercising reasonable diligence, that it has no known material conflicts of interest that would impair its ability to provide advice to Client in accordance with its fiduciary duty to municipal-entity clients and the standard of care required by MSRB Rule G-42(a)(i) concerning obligated person clients. To the extent any material conflicts of interest arise after the date of this Agreement, Advisor will provide information concerning any material conflicts of interest in the form of a written supplement to this Agreement.
- B. As part of this registration, Advisor is required to disclose any legal or disciplinary event that is material to the Client's evaluation of the Advisor or the integrity of its management or advisory personnel. The Advisor has determined that no such event exists.
- C. Copies of Advisor filings with the SEC are available via the SEC's EDGAR system by searching "Company Filings," which is available via the Internet at: <u>https://www.sec.gov/edgar/searchedgar/companysearch.html</u>. Search for "MuniCap" or for Advisor's CIK number, which is 0001614774.
- D. The MSRB has made available on its website (<u>www.msrb.org</u>) a municipal advisory client brochure that describes the protections that may be provided by MSRB rules and how to file a complaint with the appropriate regulatory authority.
- E. MuniCap is typically paid at bond closing for its EFA efforts. While this form of compensation is customary in the municipal securities market, it could present a conflict of interest. MuniCap has a fiduciary responsibility to you as our client, which means we put your interests first. The work we do for you is important to us, and we are committed to meeting this standard of fiduciary responsibility to you. We will provide you with the best advice we are able to without regards to how MuniCap is compensated.

8. This Agreement shall terminate upon the completion of the services described in Exhibit A or upon notice by either party to the other. Upon cancellation of the Agreement, Advisor shall provide to Client any work completed as of the cancellation of the Agreement and Advisor shall be compensated for services through such date.

Exhibit "A" Consulting Services Scope of Work

MuniCap's scope of services on this assignment involve being the External Financial Advisor to the District for bonds to be issued to refund the Districts' prior bonds. MuniCap's efforts will include an evaluation of the proposed refinancing bonds to determine if the terms are reasonable and providing a certification to that effect. The specific services as the EFA include the following efforts:

- Conduct the research and evaluation necessary to provide a certification as to whether the following statements are true: using criteria deemed appropriate by us and based upon our analysis of recent comparable securities or financings, we certify that the net effective interest rate (calculated as defined in Section 32-1-103(12), C.R.S.) to be borne by the bonds on bonds do not exceed a reasonable current tax-exempt or taxable interest rate; and (2) the structure of the bonds, including maturities and early redemption provisions, is reasonable considering the financial circumstances of the District.
